#### PHARMA'S POWERFUL INFLUENCE & CORRUPTION

After the United States (between 1969 to 1997) and New Zealand (1981) legalized Direct-to-Consumer Advertising (DTCA), the pharmaceutical industry began to influence the media by their massive advertising budget. By 2016, pharma's ad spending reached \$5.2 billion. Now, over 70% of media revenue comes from pharmaceutical advertising. A top TV executive told a friend of mine that the news is just a fill-in. In 1986 agents of big pharma convinced the US Congress, through fear and threats, to protect vaccine manufacturers by removing ALL liability of harm, damage, and loss of life from vaccines. This was in spite of the fact that vaccines had never been properly tested for safety and/or effectiveness. None the less, *The National Childhood Vaccine Injury Act* (NCVIA) of 1986 was enacted and signed by Pres. Reagan. Since then, over 20,000 petitions for vaccine injury compensation have been filed, 520 deaths have occurred, and tax payers have paid out over \$4.2 billion for damages and injury claims. And, only 25% of those injured get compensated.

In 2005, PREPA (Public Readiness and Emergency Preparedness Act) was passed by the US Congress and signed into law by Pres. G.W. Bush. This is a controversial tort liability shield intended to protect vaccine manufacturers from financial risk in the event of public health emergency. It also provides \$3.8 billion for pandemic influenza preparedness to protect public health in the case of a pandemic disease outbreak and preempts state vaccine safety laws.

On February 5th of this year, PREPA was activated by a declaration of public health emergency because of the so called CV-19 pandemic. As Dr. Sherri Tenpenny pointed out <https://vaxxter.com/> this provides complete protection of manufacturers from liability for all products, technologies, biologics, or any vaccine developed as a medical counter-measure against CV 19. In 1983 there were over fifty corporations controlling most of the American media, including books, magazines, music, OL newsfeeds, newspapers, movies, radio, and TV. By 1992, that dropped to half. By 2000, six large corporations took control. Today, only five dominate the industry, which are fed by two main sources.

Over 70% of media income now comes from direct-to-consumer pharmaceutical advertising. Hence, the media is no longer unbiased when it comes to areas of natural health, health/medical treatments, alternative therapies, harm from drugs, or damage done by the pharmaceutical and vaccine industries. In addition, many natural health websites, YouTube videos and documentaries, Instagrams, Tweets, FB sites, blogs, articles, DVDs, and supportive political views are being censored.
